

CREDIT FOR NON-BUSINESS ENERGY PROPERTY

Manufacturer's Certificate — Alside® Vinyl Window and Patio Door Products

Alside, headquartered at 3773 State Road, Cuyahoga Falls, OH 44223, manufactures exterior window and patio door products that when purchased with specific Low-E glass and inert gas fill options, meet or exceed the prescriptive criteria established by the American Recovery and Reinvestment Act of 2009. Such products shall qualify for the aforementioned energy-efficient, home improvement incentives that allow for a tax credit of 30% of the cost of qualifying upgrades to a maximum of \$1,500 per household for 2009 and 2010. Qualifying product criteria shall be those that meet a U-Value requirement of 0.30 or less, and a Solar Heat Gain Coefficient (SHGC) of 0.30 or less as set forth by the American Recovery and Reinvestment Act of 2009*.

Alside represents that the following families of Alside window and patio door products, when manufactured with the appropriate options, meet the requirements as stated above.


